## RESEARCH AND TEACHING INTERESTS

The aim of my work is to elucidate the religious history of Athens, especially under its democracy, as core to all the other forms or domains of its history, namely, its political, constitutional, economic, social, and military structures and development. At present I am engaged with a number of projects involving such things as sacred calendars, the laws of Solon, and the religious origins of diplomatic protocols.

Much of my work employs the evidence not only of texts but also of numismatics, epigraphy, and archaeology and it is deeply shaped by my training as an Assyriologist. Therefore, I am also deeply committed to elucidating not only the specific histories of certain communities and institutions in ancient Greece (from Athens to Macedon to Cyprus) but also the dynamic intersection between economics, religion, and governance that drove broader developments across the ancient Mediterranean world, c. 750-250.
